

# TANUNDA NETBALL CLUB

<u>By Laws</u>

Updated January 2024

#### 1. Membership

Membership shall consist of financial members who have registered and paid the applicable subscription, less any relevant discounts via the BLGNA Registration platform. Players who are registered via a Single Game Voucher (BLGNA fill in player) will also be considered members of the Club. For each year the subscription amount and discounts are decided upon at the previous Annual General Meeting. Any person who has not so paid their subscription shall be ineligible to play but subject to any special determination which may have been made by the Committee in respect of any individual player.

#### 2. Rules

All members shall be bound by the Constitution of the Club.

#### 3. Coaches

The Committee shall appoint such coach/es or assistant coach/es as may be necessary for the proper coaching of the Senior 1 and 2 teams, and shall be empowered in its absolute discretion to pay an honorarium to such coach/es or assistant coach/es as it thinks fit by way of reimbursement for travelling, outlays and other services rendered to the Club. Any such honorarium paid shall be at the entire discretion of the Committee and shall not be obligatory or in any way create any form of contract for services of employment. The coach/es shall be permitted to attend such committee meetings as the Committee requires from time to time but shall (unless an elected member of the Committee) have no voting rights.

#### 4. Team Selection

#### 5. Accidents

- 5.1 Players are to provide their own personal accident cover as the Club will not accept any liability for medical or other costs incurred due to any accident that occurs during a match (either official or practice);
- 5.2 The Club will not accept any liability for cost relating to accidents even if a member of the Club has either expressed or implied that liability exists.

#### 6. Premiership Tops

- 6.1 The Club will cover the screen printing/set up costs for any teams that win the premiership and order premiership tops each season;
- 6.2 Premiership players are to cover the individual cost of their premiership tops;
- 6.3 Any team who wishes to order either runner-up or grand finalists tops will be required to pay both the screen printing costs and the individual costs of their tops.

### 7. Trophies and Awards

- 7.1 Trophies will be awarded for the Best & Fairest, Best & Fairest Runner-Up and one Coaches Trophy, e.g. most consistent, best team player, most improved, in each competing division of the Club;
- 7.2 Best & Fairest to be decided by votes given by coaches, or delegate persons chosen by the coach, on 3 points for FIRST, 2 points for SECOND and 1 point for THIRD. In the event of there being multiple winners the executive of the Club shall make the decision which shall be final and binding;
- 7.3 All Go (formerly Netta) and Primary players will receive a medallion for their participation;
- 7.4 In the event of a team winning a premiership, the Club is not obliged to donate trophies. If any individual person/s wish to donate trophies, these are to be accepted by the Club on behalf of the team/s.
- 7.5 Life Member award to be awarded as per clause 6.5 of the Tanunda Netball Club Constitution;
- 7.6 Umpires Trophy Marjorie Lehmann Trophy to be awarded to an umpire who has shown outstanding umpire service, commitment, attitude and performance.
- 7.7 Club Person Award to be awarded to a club person with outstanding service, commitment, club spirit, performance, participation either in playing, coaching, umpiring, administration and can be selected by the Executive Committee;
- 7.8 Perpetual Trophy Thelma Murphy Trophy is to be awarded to the Most Successful Junior player who has received the highest number of votes in all of the junior grades consisting of Sub Junior, Junior and Inters for that year;
- 7.9 Perpetual Trophy Wohlers Trophy is to be awarded to the Most Successful Senior player who has received the highest number of votes in all of the senior grades for that year;
- 7.10 Any players who have participated in other affiliated competitions through the year, i.e. country champions, regional games, a certificate will be awarded to each player;
- 7.11 The Committee shall determine the type of token gift that shall be given to any Sub Junior, Junior or Inter players who receive a BLGNA Best and Fairest or a Runner Up award. This decision shall be made at the end of the minor round matches for that year.

## 8. Honorarium Payments

- 8.1 An honorarium payment may be paid to:
  - 8.1.1 An Executive Member of the Club
  - 8.1.2 A Committee Member appointed by the Club to act in a specified capacity for or on behalf of the Club
- 8.2 This payment is paid from Club funds for the member's voluntary services.
- 8.3 An honorarium may only be paid subsequent to the completion of each year of the term of office of the recipient.
- 8.4 The total of all honoraria to be paid in the next financial year of the Club shall be determined at the preceding Annual General Meeting.
